STANDARD WARRANTY

DMS International warrants to Buyer that the products sold hereunder are free from defects in material and workmanship under normal use and service, subject to the exceptions stated herein. Products purchased are warranted for a period of one (1) year from the date of shipment to the original Buyer. Those products that DMS International subcontracts and resells to original customers will carry the manufacturer's warranty from the date of shipment to the original Buyer. If any products purchased from DMS INTERNATIONAL are defective or do not conform to the contract for sale, Buyer must so notify DMS INTERNATIONAL promptly after receipt of the products and DMS INTERNATIONAL, or its authorized or designated representative, shall have the right to inspect the goods on Buyer's premises. If DMS INTERNATIONAL determines the product was defective at the time of delivery, at DMS INTERNATIONAL direction, Buyer may either return the product with shipping charges prepaid to DMS INTERNATIONAL and obtain a refund of the purchase price or may return the defective product to DMS INTERNATIONAL for repair or replacement. Claims for nonconforming orders will not be considered unless made in writing to DMS INTERNATIONAL within ten (10) days after Buyer's receipt of the products. Since DMS INTERNATIONAL responsibility ceases upon delivery of the products in good order to a carrier, any claims for damage or shortage in transit must be brought against the carrier.

DMS INTERNATIONAL warrants only that the products supplied hereunder shall conform to the specifications furnished by or approved by DMS INTERNATIONAL, that it will convey good title thereto and that the products will be delivered free from any security interest or other lien or encumbrance. THERE ARE NO WARRANTIES OF MERCHANT ABILITY, OR OF FITNESS OF SAID PRODUCTS FOR ANY PARTICULAR PURPOSE, NOR IS THERE ANY OTHER WARRANTY EXPRESS OR IMPLIED EXCEPT AS HEREIN SET FORTH.

No agent, distributor, or other party is authorized to make any warranties on behalf of DMS INTERNATIONAL or to assume for DMS INTERNATIONAL any other liability in connection with any of DMS INTERNATIONAL products.

REMEDY
